How Graft Works IGNORE THE HYPE-FOLLOW THE MONEY

The Mayor directly supervises a dozen agencies—ranging from the Criminal Justice Council to Office of Commuter Assistance. In this issue, we examine the hidden character of two of the City's most politically-charged agencies: Mayor's Office of Community Development & Mayor's Office of Housing.

MOCD funnels grant and loan dollars into the hands of its sister agencies and politically connected "non-profit" social service organizations. MOH loans and grants money to real-estate developers and facilitates deals. Both agencies are guided directly by the Mayor in determining who gets funded—and who does not.

MOCD controls an annual \$27 million disbursement of Federal Block Grant funds. MOH channels hundreds of millions in Redevelopment and Housing Bond moneys to firms in favor with His or Her Honor.

These dollars flow to organizations that support whomever is in power. There is no accountability or program monitoring. Some organizations use the funds well—others abscond with the money. Failure to deliver taxpayer-funded services carries no penalty.

The City's balance sheet carries \$63 million in outstanding loans to non-profit organizations and privately-owned firms. The

City's accountant—Controller Ed Harrington—informed SFI that his department does not possess any data on the status of these loans. SFI learned that MOCD loans had a combined delinquency and default rate of over fifty percent in 1993!

The Bureau of Delinquent Revenue wrote SFI that—since 1990—City agencies have only referred four (4) defaulted loans—totaling \$50,000—for collection. The rest were either "forgiven," or written off as bad debts.

MOH typically processes unsecured, multi-million dollar loans to developers at below-market interest rates. MOH shepherds intricate bond-financed deals through the careless bureaucracy—and makes gifts of public funds to realestate speculators. Not even Harvey Rose can keep up with MOH's

twisting trail of deeds.

To demonstrate the workings of MOCD & MOH, we picked two deals to describe in detail. The "San Francisco Senators Boondoggle" started under the Feinstein administration and has carried through to the present. Mayor Art Agnos initiated the "Geary Courtyard Bond Sham"—before he moved over to HUD. Mayor Willie Brown—and his fiscally supercilious Supervisors—can take the credit for many similar deals.

Every fact in each story is documented with public records. On-site investigation and interviews were conducted.
